What is California Proposition 65?

The Safe Drinking Water and Toxic Enforcement Act, commonly referred to as Proposition 65, was enacted in 1986 in the state of California. The core of this Act can be summarized as “right-to-know law” for consumers in California.

The purpose of the Act is to inform consumers if certain hazardous chemicals are present in a product. There are currently over 850 chemicals “known to the state to cause cancer or reproductive toxicity” listed in the Act and the list is updated at least annually.

The scope of Proposition 65 includes all consumer products sold or distributed in California. Some examples are:

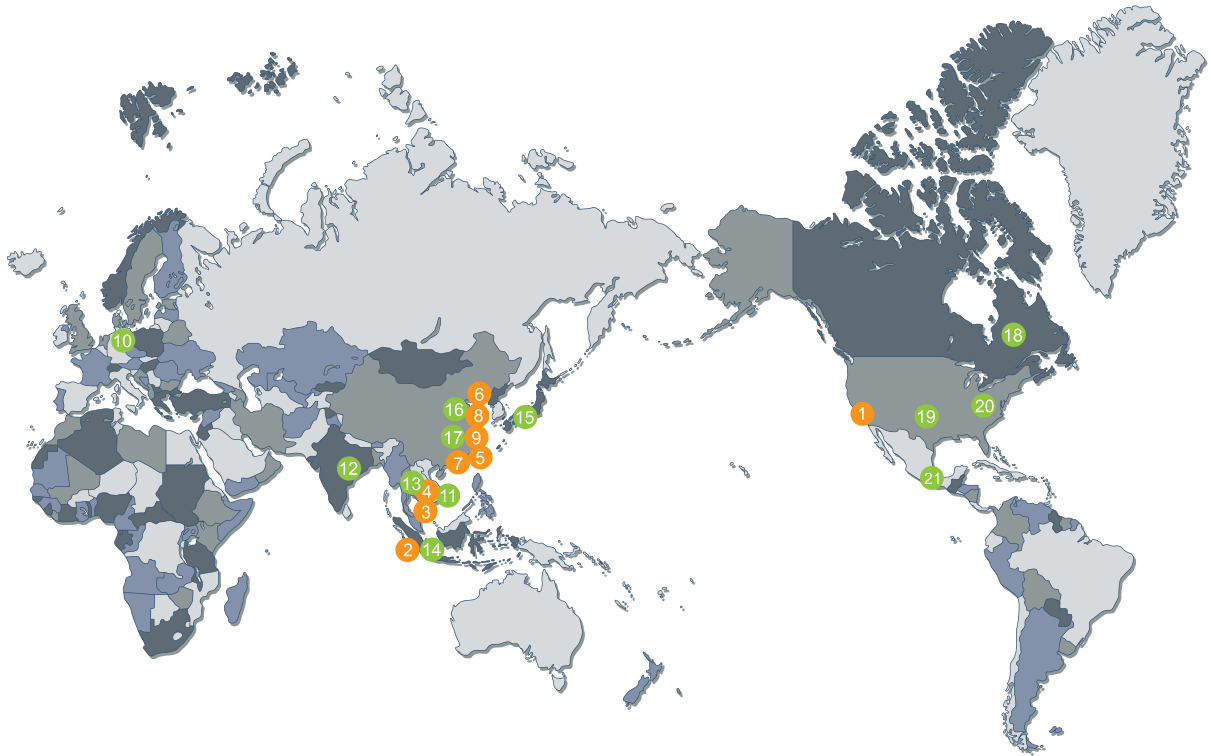
- Clothing

This is an Act that must be managed separately from the CPSIA regulations. Businesses in California must ensure that their products sold in California maintain chemical exposure levels low enough to pose no significant health risk to consumers. In cases where a product's chemical exposure levels may cause cancer or reproductive toxicity, a "clear and reasonable" warning must be attached on the product to inform the public. Violation of the law may lead to heavy penalties and cause reputational harm to businesses.
